Ofsted Inspection Outcome

As communicated to parents at the end of September, the school was subject to a Section 5 Ofsted Inspection lasting 2 days on the 24/25 September 24. The school was inspected under Section 5, because during the last Section 8 Inspection in January 2023, the school was judged to be good with declining standards.

I am delighted to inform you that following our recent Ofsted Inspection, Hellifield Primary School has secured the following judgements, which reflected my recent evaluation to the Governing Board in my Headteacher report. Please note there is no longer an overall effectiveness grade. This judgement has been removed. The report evidences that key areas previously identified in February 2023 have rapidly been addressed.

Behaviour and Attitudes: GOOD

Personal Development: GOOD

Leadership and Management: GOOD

Early years provision: GOOD

"Leaders have ensured staff receive high quality professional development."

"The Geography Leader has planned an interesting and well-planned curriculum."

"The Mathematics leader is knowledgeable and has high expectations for all pupils."

"Leaders are ambitious for the school."
